Meeting EC - EACN

From 4 to 5 February 2010, a meeting between the EU contactpoint network against corruption (EACN) and the European Commission (EC) took place in Brussels. This first meeting of exchange was attended by nearly 40 participants from 19 EU Member States who were, inter alia, updated on the Stockholm Programme and its latest developments at EU level. The EACN



President emphasised that one of the main challenges for the EACN was to bring together and enhance cooperation between its member institutions of different backgrounds and jurisdictions in order to exchange best practices and gain added value. At the same safeguarding the independence of its organisations and the network itself is key and at the top of the agenda.

A follow-up meeting was envisaged for June or July 2010.

UN Crime Congress, Brazil

From 12 to 19 April 2010, the Twelfth United Nations Congress on Crime Prevention and Criminal Justice will be held in Salvador, Brazil. Themed "Comprehensive strategies for global challenges: crime prevention and criminal justice systems and their development in a changing world", the congress will be a hub for policymakers and practitioners in the areas of crime prevention and criminal justice,



as well as for individual experts from academia and representatives of civil society and the media. Special attention will be drawn to children, youth and crime; smuggling of migrants; trafficking in persons; money-laundering and cybercrime. It would be recommendable that EPAC Partners are members of their national delegations to the conference.

PO Principles WG

In 2010, the Police Oversight Principles Working Group will continue its work to develop aspirational minimum standards for police oversight bodies in Europe. The group hopes to agree the first version of the Police Oversight Principles during this year and will promote them to EPAC Partners. The group expects to meet at least once in 2010.

AC Standards WG

In the year 2010 based upon previous achievements of the working group, the AC Standards Working Group will further develop basic standards according to which anti-corruption agencies need to be established and standards according to which those agencies should perform their functions. Important questions of independence, financial and operational autonomy, integrity and other principles will be discussed in order to prepare guidelines for the existing and new anti-corruption agencies to fulfil their tasks in a legal, professional and non-partisan manner. A lot of attention will be devoted to threats challenging the work of anti-corruption agencies in order to avoid illicit influence on and negative consequences for the performance of their tasks. A meeting of the working group in May 2010 will serve as a platform for the production of written guidelines.
