#### **EPAC/EACN Project Conference**

Under the auspices of the Hungarian Presidency of the Council of the European Union, the project conference on "European Standards for EPAC/EACN Members", took place in Budapest between 13 and 14 April. This two-day event, perfectly organised by the Hungarian National Protective Service (NVSZ), brought together more than 80 delegates from Council of Europe and EU Member States. The conference provided an occasion to further elaborate on "Anti-Corruption Authorities Standards" and "Police Oversight Principles" so that the refined documents could be brought to a standard to be presented for adoption at the annual conference.

Moreover, keynote speeches and presentations were delivered by Mr. László Felkai, Undersecretary for Administration of the Hungarian Ministry Giovanni Interior, Mr. Kessler, the new Director General of OLAF, Mr. Zoltán Bolcsik. General Director of the recently founded NVSZ, Mr. Edmond Dunga, GRECO Bureau Member, as well as Mr. Martin Kreutner.

Situated in Laxenburg, Austria, IACA aims to overcome the current shortcomings in knowledge and practice in the field of anti-corruption, improve the knowledge and skills of its participants, and assist institutions and organizations in enhancing their transparency and accountability.


#### **CACOLE Conference**

### **UNCAC IRG Meeting**

At the third session of the Conference of the States Parties to the United Nations Convention against Corruption (UNCAC), held in Doha, Qatar, in November 2009, the conference adopted the terms of reference of the Mechanism for the Review of Implementation of the UNCAC and established the Implementation Review Group (IRG) to oversee the review process.



### **SEECP Meeting**

Between 9 and 10 May, the Meeting of the South-East Europe Cooperation Process (SEECP) Directors of National Institutions and Agencies for Combating Corruption and Organised Crime will convene in Be i i (Budva), Montenegro. Under the Montenegrin Chairmanship-in-Office of the SEECP, the gathering is co-organised by the



Directorate for Anti-Corruption Initiative, Regional Anti-Corruption Initiative Secretariat, and Regional Cooperation Council.

The SEECP is a regional framework of co-operation consisting of 12 Member States, which purports to strengthen good neighborly relations and thus promote security and stability in the region.
