## **EPAC/EACN Working Groups**



The EPAC/EACN Working Groups are continuing their work and refining the draft papers on "Anti-Corruption Authorities Standards" and "Police Oversight Principles", which had been further discussed at the EPAC/EACN Project Conference in Budapest on 13 and 14 April. Recently, the Working Group on "Police Oversight Principles", chaired by the Vice-President, Mr. Nicholas Long, gathered for a

meeting. In accordance with the Oradea Declaration, we will distribute all draft papers by the end of August for your comments, and the final draft versions will be presented to the General Assembly for adoption.

#### **CACOLE Conference**

The Canadian Association for Civilian Oversight of Law Enforcement (CACOLE) held its annual conference from 30 May to 1 June at the Radisson Hotel and Conference Centre in Canmore, Alberta, with the theme "Civilian Oversight: Are We Making A Difference?".

## **EU Anti-Corruption Report et al.**

Recently, the European Commission announced the planned establishment of an EU anticorruption reporting mechanism for periodic assessment in order to implement a comprehensive anti-corruption policy in the Union. The mechanism, termed EU Anticorruption Report, shall have the following objectives:

(a) to periodically assess the situation in the Union regarding the fight against corruption; (b) to identify trends and best practices;

(c) to make general recommendations for adjusting EU policy on preventing and fighting corruption;

(d) to make tailor-made recommendations;

(e) to help Member States, civil society or other stakeholders identify shortcomings, raise awareness and provide training on anti-corruption.



The EU Anti-corruption Report, which is planned to start in 2013, shall build on cooperation with the EPAC/EACN and other networks and mechanisms.

When preparing the EU Anti-corruption Report the Commission shall cooperate with existing monitoring and evaluation mechanisms to avoid additional administrative burdens for Member States and the duplication of efforts. It shall draw on the minimum

standards against corruption established by existing international instruments such as the Council of Europe's Criminal Law Convention on Corruption, Civil Law Convention on Corruption, Twenty Guiding Principles for the Fight Against Corruption, the UNCAC and the OECD Anti-Bribery Convention.

The envisioned mechanism was presented in the course of the meeting of the Working Party on General Matters, which took place from 22 to 23 June in Brussels. On this occasion, the Hungarian Presidency of the Council of the European Union also informed on the results of the **EPAC/EACN Project Conference** held in Budapest in April of this year.

As called for by the Stockholm Programme, the Commission also submited to the Council a report on the modalities for the EU to accede to the Council of Europe Group of States against Corruption (GRECO). It is intended that the EU's active participation in GRECO's work may eventually bring benefits to both organisations, combining GRECO expertise in monitoring anti-corruption efforts and the political role of EU institutions towards an effective enforcement of anti-corruption policies in the EU-27.

## **International Anti-Corruption Summer Academy**

Between 30 June and 9 July, the International Anti-Corruption Academy (IACA) offered its first summer training programme, the International Anti-Corruption Summer Academy (IACSA), designed for anti-corruption practitioners and students specialising in the field. Under the motto "Practice Meets Science", 70 participants representing 60 countries from



around the world - many of from the them also EPAC/EACN family - partook in having IACSA. had the opportunity to analyse and better understand the highly complex phenomenon corruption in our era globalisation. The ten-day event not only included interactive lectures constructive panel discussions. but was also complimented by excursions and recreational

### **UNCAC Implementation Review Group**

In accordance with Resolution 3/1, adopted by the Conference of the States Parties (CoSP) to the United Nations Convention against Corruption (UNCAC) at its 3rd session in Doha in November 2009, the second meeting of the Implementation Review Group (IRG) convened in



Vienna from 30 May to 2 June of this year. Most notably, the role of the IRG is to ensure the efficient performance and effectiveness of the UNCAC review mechanism. During this event, the group discussed "lessons learned" related to the first year of the work of the mechanism, and pursuant to the report of this meeting, the participants noted that the mechanism was off to a good start.
