EPAC/EACN Annual Professional Conference 2012

This year's EPAC/EACN Annual Professional Conference will take place from Wednesday, 21 November, starting around noon, to Friday, 23 November 2012, closing in the early afternoon. It will be hosted by our Spanish colleagues from the Mossos d'Esquadra – Policia de la Generalitat in Barcelona. Content-wise it is foreseen that the meeting will centre around a topic from the anti-corruption field and another topic on police oversight with an additional session on whistleblowing.

Official invitations will be sent out by mid-June. We look forward to your participation.

Canadian Oversight of Law Enforcement in the 21st Century Conference



From 28 to 30 May 2012, the Canadian Association for Civilian Oversight of Law Enforcement will host a conference entitled "Civilian Oversight of Law Enforcement in the 21st Century: Technology and

Attitudes". The venue will be the International Toronto Yorkville in Toronto, Ontario.

The discussions will comprise numerous subjects related to the central theme, which is the use of technology in law enforcement. Among the subjects: the use of social media, cell phone and police video technology and their impact on police accountability; cooperation among the police boards/commissions, municipalities and provincial oversights bodies; investigative skills competencies for police officers and their applicability for policy oversight organizations; case studies on the use of technology for investigative purposes; the adequate use of force; and legal issues surrounding Aboriginal policing. The methodology of the conference includes not only panel discussion, but actual classroom training, utilizing a use of force training scenario.

The price for registrations received before 31 March is 800 CAD + 13% tax. Registrations made after 31 March will cost 850 CAD + 13% tax for members and 900 CAD + 13% tax for non-members. The prices include all meals and breaks for the duration of the event, except the Monday dinner. Reminder: IACA's Best of Seminar featuring Susan Rose-Ackerman

From 7 to 8 June 2012 the International Anti-Corruption Academy (IACA) in Laxenburg, Austria, will offer a seminar featuring the best of renowned economics and law professor, Susan Rose-Ackerman.

Covering the issue since the 1970s, Professor Rose-Ackermann will discuss the key findings of her research and the roles of international actors and nation states in both promoting and countering corruption. She will elaborate on some of the most fundamental issues that anti-corruption programmes should discuss, ranging from the design of public institutions to the use of sanctions versus rewards to control malfeasance.





Together with Professor Rose-Ackerman, participants will have the opportunity to analyze the root causes of
