#### **EPAC/EACN Annual Professional Conference 2013**

This year's Annual Professional Conference and General Assembly of EPAC/EACN will be held from Wednesday, 13 November to Friday, 15 November 2013. The 13<sup>th</sup> yearly gathering of EPAC and EACN members will be hosted by our Polish colleagues in Krakow.

Official invitations and information for participants will be sent out in due course. We very much look forward to your participation.

### **Opening Conference**

On 27 and 28 May, the opening conference of the project, "Promoting the exchange of best practices in detection, investigation and sanctioning of corruption in the EU", will take place in Bucharest, Romania. The event is organized by Romania's National Anticorruption Directorate (DNA), in cooperation with Spain's Anti-Fraud Office of Catalonia (OAC) and France's Central Service for the Prevention of Corruption (SCPC).



The overall objective of the project is to support EU anticorruption efforts by promoting the exchange of experience and good practice among EU Member States. The opening conference aims to bring together representatives from all

27 Member States from institutions with competences in detecting, investigating and judging corruption offences, such as investigating agencies, prosecution offices and courts. It will be followed by three workshops, the first focusing on detection, the second on investigation and the third on sanctioning corruption. During the opening conference and workshops, participants will have the opportunity to share the practical challenges and legislative frameworks which rule their daily tasks of prosecuting corruption.

The project will close with a final conference, scheduled for June 2014, which will provide an overview of the results of the workshops, offering a retrospective of the ideas debated during them. At the end of the project, participants will also receive a report containing the conclusions of each workshop.

This 19<sup>th</sup> edition, entitled "Finding the "Right" Balance", raises an interesting question concerning civilian oversight of law enforcement: What does it mean to find the right balance of and within civilian oversight? The conference will hold different sessions covering subject matters such as human rights and policing, technology pitfalls in law enforcement operations,

mediating citizen complaints against the police, effective reporting, immigration and policing. One of the speakers, Salt Lake City Chief of Police Chris Burbank, who received special recognition from the American Civil Liberties Union of Utah for his work in protecting immigrant civil rights, will present his view on the cross-deputization of police officers as immigration enforcement agents.

The Mentoring Program will also host an informal get together on the evening before the start of the Annual Conference. This programme offers opportunities for experienced and newer police oversight professionals to continue their professional development through formal mentoring relationships. #### **IACA's Best of Seminar featuring Robert Klitgaard**

The seminar is designed for anti-corruption experts, business and government executives, leaders of civil society organizations, journalists and academics who are interested in design management and sustainability of anti-corruption efforts. Participants will learn about the entire cycle from effective risk management, preventative measures and detection methods to concrete actions to be taken in a confirmed case of fraud or corruption in different areas.
