EPAC/EACN Working Groups Launched

Following the inquiry for expressions of interest, EPAC/EACN is pleased to announce the establishment of two Working Groups (WGs), which will hold their first meetings in May 2016.

The meeting of the WG on "Corruption within the healthcare system", chaired by the National Anticorruption Directorate (DNA) of Romania, will take place in Bucharest. The substantive themes will be based on the results of the questionnaire previously circulated by the DNA.

The WG on "Criteria for evaluation of efficiency of a Police Oversight Body", chaired by the General Inspection of the National Police (IGPN) of France, will meet in Paris.

We look forward to sharing the outcomes of both Working Groups with you in due course.

European Commission Launches Public Consultation on a Proposal for a Mandatory Transparency Register



The European Commission seeks the views of all interested parties on the performance of the current Transparency Register for organizations and self-employed individuals engaged in EU policymaking and policy implementation. This consultation aims to assess future evolutions towards a mandatory scheme covering the European Parliament, the Council of the EU, and the European Commission.

The Commission is committed to increased transparency in the way it operates, and in European Union decision-making overall. In this context, it has announced its intention to propose improvements to the Transparency Register, a tool put in place by the European Parliament and the European Commission in 2011 to cast light on lobbying activities seeking to influence European policymaking.

The purpose of this public consultation, taking place from 1 March to 1 June 2016, is to ensure that the Register maximizes its potential as a meaningful tool governing relations between the EU institutions and interest groups. The results will support the preparation of the Commission's proposal for a mandatory Register.

European Anti-Fraud Office (OLAF) Hosts and Chairs the 4th Annual Meeting of the Economic Crime Agencies Network (ECAN)

Overcoming obstacles in international cooperation and limiting the circulation of cash topped the agenda at the 4th annual meeting of ECAN hosted by OLAF from 2 to 4 March 2016 in Brussels.



ECAN is a high-level worldwide network of law enforcement organizations, primarily involved in the investigation and prosecution of economic crimes. The network counts OLAF as one of its founders, and its members include the Serious Fraud Office (UK), City of London Police (UK), the US Federal Bureau of Investigation (FBI), and the Independent Commission Against Corruption of Hong Kong, China (ICAC). ECAN encourages organizations to cooperate in the fight against complex, cross-border economic crimes, including those of a cross-jurisdictional nature, to disseminate information, and share best practices.

The reception was honoured by addresses from H.E. Ms. Margarita Popova, Vice President of the Republic of Bulgaria and the first Chairperson of IACA's Board of Governors, H.E. Mr. Yury Fedotov, Executive Director of the United Nations Office on Drugs and Crime (UNODC) and Director-General of the United Nations Office in Vienna (UNOV), and Martin Kreutner, Dean and Executive Secretary of IACA.

H.E. Mr. Fedotov also conveyed a message from H.E. Mr. Ban Ki-moon, Secretary-General of the United Nations, who congratulated IACA on its accomplishments and acknowledged the Academy's role in fighting and preventing corruption via training and education.

- The more general Integrity Track, focusing on other pressing issues such as the refugee crisis, climate change, extractive industries, and state-owned enterprises.

The objective of this year's conference is to determine whom society should blame for crimes perpetrated against it, through or with financial and business structures, with its various systems of law, compliance, or public criticism.
