EPAC/EACN Working Groups Formed

EPAC/EACN is happy to inform you that two Working Groups (WGs) were established and will begin their work shortly. The WG "Risk Management and Risk Analysis" will be chaired by the Austrian Federal Bureau of Anti-Corruption (BAK), while the WG "Analysis of Big Data, related Legal Aspects, Use of Databases" will be chaired by the Special Investigation Service of the Republic of Lithuania and co-chaired by the Romanian National Anticorruption Directorate (DNA).

The results of their work will be presented at the Annual Professional Conference and General Assembly.

Final Session of the EPAC/EACN Working Group "Criteria for Evaluation of Efficiency of A Police Oversight Body"

The EPAC/EACN WG "Criteria for Evaluation of Efficiency of a Police Oversight Body", which was initiated and chaired by the General Inspectorate of the French National Police (IGPN) in 2016, will hold its last meeting in Luxembourg on 6 April 2017, where the result of the WG's work, the "Handbook for evaluating the effectiveness/efficiency of police oversight bodies", will be presented to and discussed with the EPAC/EACN members having participated in this WG.

17th IACC Hosted by Panama in December 2016

The International Anti-Corruption Conference (IACC) takes place every two years in a different part of the world and brings together heads of state, the civil society and the private sector.

17th IACC in Panama City:

More than 1,600 people from around 130 countries gathered in Panama City, where the Panama Declaration "Time for Justice, Equity, Security, Trust" was published on 4 December 2016. Among others, the following topics were discussed during this four-day conference: the Panama Papers, corruption and migration, tax havens, shadow economy, justice and impunity, SDGs and human rights, cooperation with the business sector and citizen participation.

The participants also reflected on the critical role of the media and investigative journalists. Furthermore, they agreed that there should be increased cooperation with anti-corruption champions as well as well-minded business and that the rise of autocracy around the world must be prevented.

The 18th IACC will take place in Denmark in 2018.

Seminar of the General Inspectorate of the French National Police

On 17 January 2017, the General Inspectorate of the French National Police (Inspection Générale de la Police Nationale, IGPN) organized a one-day internal seminar. 120 participants from all departments and bureaus of the Inspectorate were invited to discuss the following topics:

- results of the roadmap and the Inspectorate's development over the last two years
- strengthening the cohesion of the Inspectorate's employees and, thus, allowing for agents with different profiles to meet and exchange experiences
- courses of action to fuel the 2017-2019 roadmap

The event ended with the Inspectorate's traditional New Year wishes ceremony, which was attended by the Police Commissioner of Paris and the Director-General of the National Police.

Corruption Perceptions Index 2016 — a Quick Look at the Situation in Europe

At the end of January 2017, Transparency International (TI) published the Corruption Perceptions Index (CPI) 2016 which ranks 176 countries and territories based on how corrupt a country's public sector is perceived to be. None of the countries and territories got the perfect score of 100 points. Denmark took the top spot with 90 points, while Somalia was the worst performer (10 points).

With a few exceptions, there is no dramatic change in the ranks of the EPAC/EACN member states. This shows that the situation has not deteriorated. However, there is still potential for improvement in the fight against corruption. According to TI, the following problems have to be addressed: lack of integrity in democratic institutions, weaknesses in law enforcement and capture of political decision-making. TI recommends focusing not only on a comprehensive legal framework, but also on the implementation of anti-corruption provisions. Nevertheless, the overall picture shows that European countries meet high standards and that their efforts bear fruit.

Furthermore, it will focus on the question how increased integrity standards contribute to inclusive growth in various fields, such as public administration, institutional oversight, infrastructure and revenue collection.

The forum brings together relevant policy communities, the private sector, civil society organizations and academia. It aims to provide latest insights as well as instruments to foster equality and protect the policy cycle from undue influence.
