#### HIGHLIGHTS FROM THE 23RD EPAC/EACN CONFERENCE IN BUCHAREST

The 23rd Annual Professional Conference and General Assembly of the European Partners Against Corruption (EPAC) and the European Contact Point Network Against Corruption (EACN) took place on November 26–27, 2023, in Bucharest, Romania. The event convened 170 participants representing nearly 100 institutions from over 30 countries, under the inspiring theme "Together for Integrity."

The event in Bucharest was attended by 170 participants representing nearly 100 institutions from over 30 countries. Presentations were given by representatives of the UNODC, Council of Europe, European Commission, European Public Prosecutor's Office, Europol, the U.S. Department of Justice, and anti-corruption bodies from other countries.

As stated by **Ovidiu-Ciprian Antohe, Director of the General Anticorruption Directorate (DGA)** within the Romanian Ministry of Internal Affairs: "Corruption is a complex issue that transcends national borders, a worldwide plague that affects all societies and all aspects of social life, making it challenging for any single institution or country to effectively address it alone. Our almost 20 year experience with national and international partners has shown that sharing best practices, knowledge and resources is the best way to achieve tangible results in this field. This Conference provides an exceptional opportunity to enhance international cooperation in the field of integrity and to strengthen our shared efforts to prevent and combat corruption. Through open dialogue and exchange of experiences among experts from various countries, we actively contribute to developing more effective responses to corruption".







"The topic of the Conference perfectly reflects the essence of our mission: integrity and transparency are the foundation of trust in our societies. This is a core principle of our work. However, achieving integrity is only possible through unity — when representatives from different countries, institutions, and sectors join forces to combat corruption," said Linas Pernavas, EPAC/EACN President and Director of the Special Investigation Service, during his opening speech.

The Conference primarily focused on the challenges of investigating international corruption crimes, with significant attention given to innovative tools and methods for investigating financial crimes, high-level corruption cases, and international bribery investigations, as well as asset recovery procedures related to proceeds from corruption-related criminal activities. Breakout sessions explored the growing importance of big data analytics, its proactive use in uncovering corruption-related crimes, identifying potential corruption risks, contributing to the initiation of investigations, and successful case resolution.





#### DAY 1: DRIVING STRATEGIC DIALOGUE AND OPERATIONAL COLLABORATION

The conference opened with a warm welcome from Mihai Bârlici, EPAC/EACN Deputy Vice-President and Director of the Prevention Directorate, Romania's Anti-Corruption General Directorate (DGA). Dignitaries Marian-Cătălin Predoiu, Vice Prime Minister and Minister of Internal Affairs of Romania; Linas Pernavas, EPAC/EACN President and Director of Lithuania's Special Investigation Service (STT); and Ovidiu-Ciprian Antohe, General Director of the hosting institution, set the stage by emphasizing the need for robust cooperation to counter corruption's global challenges.



The keynote speech by Laura Codruţa Kövesi, European Chief Prosecutor, underscored the European Union's steadfast commitment to combatting corruption and safeguarding financial interests.

The first session featured insights from esteemed experts like Brigitte Strobel-Shaw (UNODC), Livia Stoica Becht (GRECO), Jeroen Blomsma (European Commission) and Marius Ionuț Voineag (Romania). They shared updates on the strategic frameworks for preventing corruption and fostering international collaboration.

Thematic panels explored innovative tools and strategies for tackling high-level corruption and fraud. During the panel "Investigating and prosecuting corruption and fraud", led by Simona Mihaela Prescorniță (Romania), featuring Dana-Manuela Ana (European Delegated Prosecutor) on cross-border cooperation, Burkhard Mühl (Europol) on financial investigation advancements, Radu Florin Ionescu (Romania) on high-level case investigations and prosecutions, and Peter Halpern (USA) on combating corruption, created a robust operational plan for stakeholders.





The conference significantly focused on investigating and preventing corruption. Panels focused on the crucial aspects of financial investigations, showcasing new tools and developments, including advanced digital solutions that play a significant role in tracing illicit activities.

Break-out sessions provided platforms for more focused discussions. Topics ranged from the use of technology in corruption investigations to the best practices in asset recovery and the challenges of transnational corruption prevention.



The breakout sessions allowed participants to delve deeper into specialized topics:



- Best practices in investigating transnational corruption. Highlighted by Alexis Durand (France), Semen Kryvonos (Ukraine), Neil Walsh (GlobE), Romulus Nicolae Ungur (Southeast European Law Enforcement Cenre) the session explored best practices and operational platforms for international collaboration. The session's moderator was Burkhard MÜHL, Head of the European Financial and Economic Crime Centre at EUROPOL.
- Contemporary challenges and opportunities in investigating corruption and fraud. Panellists Maris Urbans (OECD), Mădălina Tiţa (Romania), Ziya Hajiyev and Isfandiyar Hajiyev (Azerbaijan), and Tomas Verpečinskas (Lithuania), along with moderator Cosmin Daniel Hălălău (Romania), discussed their experience in investigating corruption cases.
- Challenges associated with identifying and recovering criminal assets. Moderator Cornel-Virgiliu Călinescu (Romania), alongside experts Marjolijn Van Der Hart (Netherlands), Peter Halpern (US), and Jurgita Stefanovičienė (Lithuania), presented innovative approaches to recovering illicit assets.
- Risk based approaches in preventing corruption and fraud. Moderator Ernst Schmid (Austria) led a session on customized anti-corruption strategies, featuring Viktor Pavlushchyk (Ukraine), Manuel García Bernárdez (Spain), Louise-Marie Petrovic (Austria), and Mihai Bârlici (Romania).

Lucile Roland (France), EPAC/EAC vice-president, moderated the segment "Preventing Corruption and Integrity Building in Law Enforcement." exploring integrity-boosting mechanisms and strategies for European law enforcement.





Livia Stoica Becht (GRECO) shared findings from GRECO's 5th round of evaluations, which assess the effectiveness of measures in place to prevent and combat corruption in member states.

Following GRECO's insightful presentation, Romania's DGPI representatives facilitated a focused discussion on their internal security measures, particularly pre-employment vetting and background checks for classified information access.



The plenary discussions set the stage for more focused break-out sessions where experts from across Europe shared insights into the challenges and innovations in their fields.








• Challenges and new developments on combating corruption and improving resilience of police profession. Manuela Popescu (Romania) moderated a session with insights from Willem Jan de Koning and Simone Zwaan (The Netherlands), Adrian Radu (Romania), and Carlos Agudo (Spain). Discussions focused on leveraging technology to combat corruption and enhancing internal monitoring to maintain law enforcement integrity.



• Insights from Situational Reports on Corruption. Moderated by Ernst Schmid (Austria), this panel featured Ana-Lorena Sava (Romania), Louise-Marie Petrovic (Austria), and Valentin Gabriel Topoloiu (Romania), who shared updates on national anticorruption strategies and the impact of data-driven approaches on policy-making.





#### **DAY 2: BUILDING RESILIENCE AND FOSTERING COOPERATION**





The second breakout session, moderated by Silviu Ioan Popa (Romania), examined how automated tools maintain integrity in public offices. Among the speaker were Bruno González Valdelièvre (Spain), Laura Valli (Italy), Jeanne Ollivier (France), Viktor Pavlushchyk (Ukraine).

This session will provided a platform to explore the transformative potential of these tools, including their usage for various purposes, such as online disclosure of financial interests, automated verification of assets declaration, prevention of conflicts of interest, or raising awareness towards integrity incidents.

The second day emphasized resilience in anti-corruption frameworks. Ana Revuelta Alonso (UNCAC Coalition) provided insights on civil society engagement, Florin Moise (Romania) discussed integrity IT tools, Agnieszka Kwiatkowska-Gurdak (Poland) highlighted the CBA's initiative, and Egidijus Radzevičius (Lithuania) presented a comprehensive strategy for Lithuania's STT; these contributions, discussed at length, collectively demonstrated a firm resolve to align preventative measures, enforcement actions, and public awareness campaigns.

Cornel-Virgiliu Călinescu (Romania) presented proposals for a new international cooperation instrument focused on criminal asset recovery, underscoring the need for global coordination.

A special breakout session, moderated by Andrei Furdui (Romania), celebrated the 25th anniversary of the OECD Anti-Bribery Convention. Panellists discussed its transformative impact and highlighted ongoing reforms across partner nations, showcasing successful case studies from France, Latvia, and other countries. Among the speakers at the session are Anca Jurma (OECD Anti-Corruption Network for Eastern Europe and Central Asia), Hendrik Bosshammer (OECD South East Europe Division), Angélique Ivanciuc (France), and Andrejs Lisenko (Latvia).





#### **EPAC/EACN AWARDS FOR EXCELLENCE IN ANTI-CORRUPTION INITIATIVES**

The announcement of the EPAC/EACN Award for the most innovative anti-corruption project was another highlight, recognizing outstanding achievements in advancing integrity and oversight.

Five nominations for the EPAC/ EACN Award were presented:

- Anti-Corruption Collective Action Impact Centre initiated by International Anti-Corruption Academy (IACA)
- Innovative awareness raising activities to support integrity development processes in the society initiated by National Protective Service of Hungary
- FIDIAS OBSERVATORY (Enhancing integrity through the social research and analysis) initiated by Andalusian Anti-Fraud Office (OAAF)
- Monitoring system of public contracts ("Mo.Co.P.") initiated by Guardia di Finanza
- Strengthening the bounds and the visibility of the anticorruption Law enforcement European community through the EMPACT framework initiated by Central Office for the Fight against Corruption and Financial and Fiscal Offenses (OCLCIFF).







This year's award went to the National Protective Service of Hungary for their initiative on Awareness-Raising Activities Support Integrity Development Processes in Society. Their program includes educational aimed at inspiring value-based behaviours in younger generations and promoting through positive, value-driven integrity communication. Their initiatives involves an ethics and integrity educational program for teachers to inspire Generation Alpha and Z with value-based behaviours, and a flexible educational package for law enforcement students (Generation Z) to enhance responsibility and awareness in combating corruption.

These thematic visits are not just meetings; they are a platform for exchanging best practices, gaining new insights, and collaboratively forging paths toward a more transparent society. Each visit is an opportunity to foster an environment of learning and mutual support, where participants can share experiences and develop new strategies to enhance their anti-corruption initiatives.

#### **ADOPTION OF THE BUCHAREST DECLARATION**

The conference was a momentous occasion marked by the adoption of the **Bucharest Declaration**, a resolution affirming the shared commitment of nations to intensify efforts in combating corruption and fostering integrity. This declaration emphasizes the collective role of governments, institutions, and societies in building transparency and trust.

The EPAC/EACN Bucharest Declaration has been officially sent to high-ranking officials and entities deeply engaged in the fight against corruption on an international scale. The recipients of the declaration include Eurojust, the European Commission, the European Committee of the Regions, the European Economic and Social Committee (EESC), the European Parliament, the Group of States against Corruption (GRECO) of the Council of Europe, the OECD Working Group on Bribery in International Business Transactions, the OECD Anti-Corruption Division, Directorate for Financial and Enterprise Affairs (DAF), and the United Nations Office on Drugs and Crime (UNODC).

The EPAC/EACN Secretariat is actively encouraging its members to disseminate the message about the adoption of the Bucharest Declaration within their respective countries and to undertake further necessary actions to implement the suggestions outlined in the declaration. By promoting the principles and actions stipulated in the Bucharest Declaration, EPAC/EACN seeks to reinforce the collective efforts in combating corruption and promoting integrity among public institutions, thereby contributing to the creation of a more just and ethical society.

#### Dear Colleagues,

Next year, Europol will host a conference that puts fundamental rights at the heart of policing. We are gathering law enforcement leaders to examine if and how violations of fundamental rights occur within policing, as well as how they are caused and what initiatives are underway to prevent such infringements.

We will ask: how does law enforcement implement new technologies in a fundamental rights-compliant way? Many good practices exist already, and this conference is the opportunity to learn from colleagues, national and European organisations, and the private sector.

#### Why is Europol hosting this event?

Law enforcement have a monopoly on force, but are legally bound to respect fundamental rights in all police actions and activities. These actions and activities, as well as the mentality of law enforcement staff, are often criticised by civil society and the press. Studies such as a recent publication of the FRA mention the discrimination and racism still present in police forces. Others highlight the difficulties in respecting fundamental rights at borders. Meanwhile today's police grapple with criticism stemming from the use of technology, with some fearing fundamental rights are at risk. Furthermore, the community of law enforcement is not immune to tendencies emerging all over the world, such as political polarisation.

Nonetheless, law enforcement's mission is to protect people from violations of human rights. As a result, police forces across Europe go to incredible lengths to ensure fundamental rights are protected and respected. Community policing initiatives emerge, and fundamental rights trainings are growing - from academic courses to more focussed trainings. At the same time, law enforcement bodies are developing methodologies to assess the fundamental rights compliance of new police techniques.

At this conference, Europol will bring together a wide array of people and perspectives to delve deep into one of the biggest challenges facing law enforcement today. I hope that you can attend and be part of this event, which I believe offers benefits across policing and beyond.
